Developed, Directed the first Camp Abilities: A sports camp for children with visual impairments, blindness, or deafblindness at the College at Brockport in 1996. Since then we have served over 900 children with visual impairments. We have trained over 1,300 professional preparation students on how to teach children with visual impairments.

The Camp Abilities model has been adopted in over 12 states, one territory, and four countries. Over 800 children have been exposed to sports and recreation due to this experience and over 1,000 university professional preparation students have been trained to teach children with visual impairments due to this program.

Over \$1,000,000 has been obtained for Camp Abilities at Brockport, and 27 research papers and four books have been published due to the program.
